Bye- Law - Page 15 – Section 29 (a),(b),(c),(d),(e),(f),(g) and should satisfy the following criteria:

- Shall be in continuous good Membership Standing for a minimum of twelve (12) months.
- Shall be over the age of eighteen (18) years.
- Shall not be delinquent in loan payment in **VENTURE** Credit Union or any other Financial Institution.
- Shall not be an employee of **VENTURE** Credit Union or any other Co-operative
- Shall not be on the Board of Directors or Committee of any other Credit Union.
- Shall never have declared bankrupt, or have been convicted of any indictable or fraudulent offences.
- Shall be recommended by two (2) **VENTURE** members in good financial standing.
- Shall possess training and or working experience in relevant area of expertise.
- Shall be compliant to all bye-laws and regulations which govern **VENTURE** Credit Union Co-op. Society Ltd.
- Shall be willing to give generously of your time to attend meetings and/or events and other associated credit union movement activities.
- I hereby authorize and consent to **VENTURE** Credit Union receiving any financial and other information about me from any of its subsidiaries, agents, third party assignees, other financial institutions, Credit Bureaus, other person or Corporation, with whom I may have or propose to have financial dealings from time to time.
